DIB examination & registration fees will be collected through mCash and for this,-

The candidates from other banks may pay fees from any branch of IBBL, nominated agent of IBBL & Mobicash agent to the said mCash account. After each successful transaction, the applicant will receive an SMS where the **Transaction ID** of the transaction will be available.
2. At the time of filling up of online entry form for the examination, the applicants have to insert their **Transaction ID** received through SMS.
3. If the transaction is not performed from the mobile number of the applicant from IBBL which was entered at the time of registration, the transaction will not be considered as a valid transaction.






