Dr. Jason West

Dr. Jason West is Assistant Professor in Finance at Griffith University in Brisbane, Australia. Jason has held senior industry appointments with BHP Billiton, Commonwealth Bank, ANZ Bank, Standard Chartered Bank and OCBC Bank and has worked extensively throughout Europe and Asia in both banking and the resources sector. His research has developed new approaches to the modelling of risk and the pricing of financial instruments in the energy sector as well as devising new approaches to understanding the dynamics of resource economics. He has also developed advanced methods for commodity price modelling, insurance derivatives and the funding of infrastructure projects. His qualifications include a PhD in quantitative finance from the University of Technology, Sydney as well as higher degrees in mathematics and finance from the University of New South Wales. He is a Fellow of the Financial Services Association of Australasia (Finsia), a Member of the Society of Petroleum Engineers (SPE) and a Member of the International Association for Energy Economics (IAEE).
